This application, if approved, does not dispense with the holder thereof complying with all terms and conditions of any municipal by-law or zoning regulation.

REQUIRED DOCUMENTATION (Application will not be processed until ALL information is submitted)

- ☐ Copy of the current land title certificate
- ☐ Sketch of the affected property showing the location and details of proposed sign including size of sign, wording / message, colours, details of sign construction, location setback etc.
- ☐ Written permission of the landowner if the sign is to be placed off-premises
- ☐ Application fee payable to **Minister of Finance**

A separate application form is required for each proposed sign. Only one application fee is required if the proposed signs are on the same property.
