2. To manage, handle and administer the property referred to in paragraph #1.
3. To make an inventory of the property of the vulnerable person and to file an accounting of the property, debts, liabilities, receipts and disbursements of *The Vulnerable Persons Living with a Mental Disability Act* and regulations.
4. As a fiduciary, to perform the duties and exercise the functions of a substitute decision maker diligently, with honesty and integrity and in good faith, for the benefit of the vulnerable person.
