A \$20.00 permit fee must accompany this application.

- Allow up to **28 working days** for this application to be processed. **NOTE: It is your responsibility to ensure the application is submitted in a timely manner to accommodate any shipping arrangements you made.**
- Make your cheque or money order payable to "The Minister of Finance." **This application will not be processed without payment.**
- Flat tanned hides of big game and fur bearing animals do not require a permit.
- Your shipment may be inspected before a permit is issued.
- There are two pages to this application form. Ensure that both pages are completed and submitted with your application.

- IF YOU ARE EXPORTING OUT OF CANADA:**
- Upon receiving a Manitoba export permit, a CITES export permit may also be required prior to exporting animals such as sandhill crane, black bear, polar bear, wolf, bobcat, lynx and otter.
