

**AMENDING AGREEMENT to COMPANY AGREEMENT**

BACKGROUND:

- A. Manitoba and the Company entered into an Agreement dated <Date> ("Company Agreement") whereby in consideration for payment of a financial contribution by Manitoba, the Company agreed to deliver the Project under the Manitoba Program in accordance with the terms and conditions of the Company Agreement;
- B. Manitoba and the Company wish to amend the Company Agreement as set out in this Amending Agreement.

NOW THEREFORE in consideration of the mutual covenants contained in this Amending Agreement, Manitoba and the Company agree as follows:

- 1. The preamble is incorporated into and forms an integral part of this Amending Agreement.
- 2. The definitions, terms and conditions set forth in the Company Agreement are incorporated into and form an integral part of this Amending Agreement, except to the extent that they are modified by this Amending Agreement.
- 3. Schedule(s) <Insert A and/or B> of the Company Agreement are fully replaced by the attached Amended Schedule(s) <Insert A and/or B>.
- 4. Clauses 5.2, 5.3, 5.4 and 5.5 of the Service Agreement are fully replaced by the following new Clauses 5.2, 5.3, 5.4 and 5.5.

5.3 Subject to the terms and conditions of the Agreement the Maximum Contribution Amount set out in section 5.2 shall be allocated during the Term of this Agreement as set out in the following chart:

5.4 Notwithstanding sections 5.1, 5.2 and 5.3, Manitoba may, in its absolute discretion, reduce the Maximum Contribution Amount:

- (a) where the Legislature of the Province of Manitoba does not duly appropriate the funds payable by Manitoba under this Agreement in the Fiscal Year in which they are required; and
- (b) where the Government of Canada funding levels for the Manitoba Program are reduced.

5.5 Subject to the terms and conditions of this Agreement, Manitoba shall pay the financial contribution towards the Project to the Company in the following manner:
